

ALOE VERA TANÚSÍTVÁNYOK

Részletes tájékoztató a tanúsítványokról, melyekkel az ESSENS termékek alapanyagait gyártó cég rendelkezik:



Ez egy minőség tanúsítvány, melyet egy nemzetközi non-profit szervezet állít ki, az **"International Aloe Science Council"**, akik az USA-ban találhatóak és kizárólag aloe vera termékekkel foglalkoznak.

Ez a két tanúsítvány az 1979-ben alapított amerikai **"International Certification Services Inc."** által kerül adományozásra, amely szervezet kizárólag olyan mezőgazdasági termelőket és élelmiszeripari vállalatokat minősít, melyek ökológiai és a környezetvédelmi szempontból megfelelő módon termelnek, vegyi anyagok használata és genetikai módosítások nélkül.

Ezt a tanúsítványt az USA-ban törvényi előírások szabályozzák, különböző kategóriákban adható, úgymint mezőgazdasági feldolgozó, gyártó, stb. Ezek a tanúsítványok biztosítják az ügyfelek számára a garantáltan organikus előállítású nyersanyagokat.

Az "Aloe vera" beszállító két minőségi tanúsítvánnyal is rendelkezik:

USDA National Organic Program – Ez a tanúsítvány biztosítja, hogy az alapanyagok organikus módon lettek előállítva és megfelelnek az USDA "National Organic Program" szabványainak.
